Thursday, 16 September 2021:

I'm happy to be sharing the latest update on CSM Gramins. He has been released from the hospital and is back home recovering. Dave & his family have been looking forward to this day for months. Please continue to say prayers that he continues to recover and does not have to return to the hospital.

From COL "Skip" Pochowski:

Dave just called and he is home! He feels great and is looking to get his life back again. I think the dog forgot who he was and he attacked him, and Dave had to go back to the hospital for surgery (JUST KIDDING!!!)

He is looking forward to a ride-along on the golf course in early October as a goal for him. I hope to make this happen.

Thank you God and feel free to pass this along to everyone who knows Dave.

Thursday, 2 September 2021:

At this point in time David is tube free! He is eating on his own and the infection is clearing. Everything is working except the kidney which is only at 7% function at this time but he was reduced to dialysis twice a week instead of three. Still having sharp drops in blood pressure when standing up but not every time so that's something. Now the rehab has to start in earnest and he's ready. He is sick of hospital food. I do sneak in some contraband when he has a craving like summer sausage etc. He is reading the paper every day and is now allowed

more visitors in a day but only one at a time. Please let me know if anyone wants to visit him. You can text me at 1-414-218-5645 or phone 1-262-782-5645. He wants to come home so badly and eat my cooking which makes me question his ability to think clearly but that's another story.

Monday, 2 August 2021:

David had surgery Monday (7-26-21) afternoon to have the ostomy reversed. It went well with no problems. Now we wait for the old plumbing to kick in so his body can absorb more nutrients. They left the feeding tube for now until he can eat solid food.

Another hurdle. He is on a medication to keep his blood pressure more stable so he hopefully won't have more of the fainting spells when he tries to stand.

Tuesday, 20 July 2021 (from Goldie Schuh):

Sharing the below email from Nora Gramins. I also had a chance to speak with Dave on Sunday. Things are looking up right now for his release from the hospital and going home for further recovery. This has been a very long road for Dave & Nora. But, don't stop sending your prayers, he still has a way to go before he is back up and around. He has lost more than 50 lbs and is quite weak. Wanted to me to pass along all the well wishes and prayers being sent his way.

Saturday, 17 July 2021:

David called 911 for himself to get out of the 'rehab' facility he was in after repeatedly calling for help with his stoma bag. His stomach acids were literally burning his skin around the stoma and the feeding tube. Needless to say he is not going back there.

Side note: DO NOT SEND ANYONE YOU LOVE TO ARIA

BROOKFIELD REHAB! (Opinion)

He is safe in Elmbrook Hospital and they are deciding what the next step is. He has had consults with various doctors about possibly removing his feeding tube but he has to show them he can eat well enough to do that. In an ideal world his stoma could be eliminated if he is strong enough to withstand the surgery. The goal is to come home and get help when needed. Right now the biggest issue is his blood pressure dropping drastically when he stands up. Some days he's fine and can walk with a walker but other days if he doesn't sit down as soon as he feels dizzy, he passes out. Not good. They are trying a medication to raise his blood pressure right before he gets up. He will have to go to dialysis until such time that his remaining kidney can do the job.

The last week has been a nightmare but we will triumph!

Sunday, 4 July 2021:

David is doing well, or so I am told, medically but there are many glitches along the way. One day he will be alert and talking clearly, is able to go through his therapies without too many problems and the next few days is back to square one. Very frustrating. His blood pressure is up and down but when it is down he has more problems. He is gaining some weight but they are also tube feeding him in the

late evening. He will heartily eat what he orders most days and other days not so much. No one seems to have any definitive answers but they keep trying. We will take him foods he normally craves and it just sits there. Puzzling.

I am plugging along and Meg, Jeff and various friends will take turns visiting him. They are still only allowing one person per day from 6-8 weekdays and 3-5 on weekends. Another frustration. Other hospitals have expanded to two visitors per day so maybe soon.

Many of you have been asking if there has been update to Dave's condition. I received the below email from his wife this morning. Please continue to send your prayers. If you are interested in sending him well wishes, the family has requested you use their home mailing address:

David is getting tube feeding and vitamins through his IV. The vomiting has subsided but the hiccups just don't want to quit. It's so hard to

watch and he's barely understandable because the hiccups are constant. He's been up in a chair and wants to do more but the meds to try to control the hiccups make him so tired. We are both tired and frustrated. So are his battery of doctors. As one of them said "nothing is easy with him". Sad but true. He has odd reactions to some meds but they have to keep trying to get him back to some degree of normalcy.

Friday, 7 May 2021:

David went into surgery at 8:15 this morning. The doctor came to talk to me around noon to tell me everything went well. They put a feeding tube into his small intestine so the nutrients could be absorbed. They took care of adhesions that were basically inhibiting some function.

They found some old blood etc. that they vacuumed out and checked around in there for any possible leaks. Looked good. He finally made it up stairs about 2:00 this afternoon. He is in a beautiful room with a great view of the north including Holy Hill. Maybe it's a sign that he is being watched over. His student nurse is the daughter of his favorite dialysis nurse and many of the staff on the 6th floor (surgical) remember him from his initial surgery on Mar. 22.

I'm tired but hopeful this will turn things around.

Thursday, 22 April 2021:

Yesterday was a great day. He woke up and he was hungry. Meg went to see him, first time in a month and she walked into the room and said Hi Dad and he smiled and said Hi back. That's a big deal. He ate and drank on his own. The huge smiles from all the doctors, nurses

and therapists was a sight to see. He talked to people, sat up on his own. Swung his legs to the side of the bed and stood, with help, and sat in the chair. Then he wanted to call me so they got him a phone. You can imagine the thrill I got to hear him. Banner day for sure. He was taken off Paxil and a few other drugs that can cause sleepiness and evidently that was a good call. Biggest hurdle right now is stopping the daily hiccups. They are exhausting. Can you imagine your diaphragm spasming constantly all day? He had dialysis yesterday and the machine was acting up so he is having it again this morning. Makes him tired.

Tuesday, 20 April 2021:

The below email was received from CSM Gramins' wife, he had a minor setback. Please continue to send your prayers to him and his family.

David was transported to the rehab hospital Last Thursday evening. Things did not go as planned. He became very lethargic and he refused to eat or drink anything. By Sunday it was decided he should go to the hospital. I requested Elmbrook but was told that the ambulance would only transport to the closest hospital. Rehab called me at 5:30 PM to tell me the ambulance was on the way within the hour. So Meg picked me up and we went to Waukesha Memorial. 3 hours later he arrived. The ER staff did an amazing job of getting him diagnosed and started him on antibiotics because he had contracted pneumonia. Well, we (Meg, Jeff, Beth & I) thought he was going to be admitted but NO. The Hospitalist came in an hour later to tell me he had to go to Elmbrook because that was where he had the surgery that started all of this. But first the Elmbrook Hospitalist had to accept him and one of the surgeons had to agree, then find him a room. What

with covid protocols only one person could stay with him so Meg was confined to a socially distant visitors lounge and Jeff & Beth went home. I relayed info to Meg by texts or walking to the lounge and then she relayed to J & B and Tom. Tom went to my house at 10:30 to pick up my dogs. The ambulance came and he was taken to Elmbrook. Meg dropped me off at my house at 1:00 AM. He had more bloodwork a Head CT Scan and an Abdominal and Pelvic CT Scan. No definitive results so far.
I am tired. It's one month today since the surgery.

Friday, 16 April 2021:

David was transferred to Rehabilitation Hospital of Wisconsin yesterday. He arrived via ambulance and HE WILL WALK out of there in a few weeks. He has a direct phone number there 262-521-8904 if anyone wants to cheer him up. He is still weak with very little appetite hence 190 lbs down from 220 a month ago. Hopefully this will get him up and about. He will be having 3 types of therapy every day between 10:30 AM and 2:30 PM. He has a very nice large window in his room with a nice view.

Keep up the prayers and thank you all so much.

Thursday, 15 April 2021:

It is now day 25 and Dave is still in the hospital. All tubes are gone and he is eating some. He has no appetite. They stopped the antibiotic and some of the dizziness is gone. He's very weak but the therapists are on the ball. The intention is to get him transferred to the Rehabilitation Hospital of Wisconsin in Waukesha. The facility is highly

recommended and I have visited a friend there in the past. It is one of the few in this area.

Docs said that nothing will happen or be decided until Monday. For you lovely friends who are concerned about me, rest easy. I am doing OK as long as I see steady improvement and his desire to fight. My dogs are my comfort and constant companions along with the support of my family and friends.
