## **Wristband sales help US troops and their families**

Freedom bands, Inc. has donated \$10,000 to the Armed Forces Relief Trust (AFRT) to provide emergency funds for soldiers and their families, making good on its promise to donate all after cost revenue to the AFRT. ## **Unlimited Commissary Privileges for Guard and Reserve Hits One Year Mark**

If you're a "gray area" retiree or family member, you recently celebrated your first anniversary of unlimited commissary shopping and Defense Commissary Agency (DeCA) officials want to make sure you know about it.

Previously, Guard and Reserve members had been authorized only 24 commissary shopping days per year. The FY04 National Defense Authorization Act granted members of the Guard and Reserve, authorized family members and "gray area" retirees unlimited commissary shopping privileges.

These families are discovering average commissary savings of 30% or more can help their grocery budgets now that there are no limits to their shopping days.

Unlimited shopping privileges also eliminated the additional costs of producing and administering the pink Commissary Privilege Cards, which were initiated by commissary employees whenever Guard and Reserve personnel shopped.

## Changes in Reserve retirement proposed

Senator Lindsey Graham (R-SC) will introduce legislation in the US Senate to change the retirement pay structure for Guardsmen and Reservists, according to the February 21 edition of the *Army Times*. Senator Graham is proposing a sliding scale to reflect age and years of creditable service toward retirement. Basically, the proposed system would allow an eligible Reservist to begin collecting a pension each year under age sixty (60) for every two (2) years of creditable service over twenty (20) years. For example, a retired Reservist could begin collecting his pension at age 59 with 22 years service, age 55 with 30 years service and all the way down to age 53 with 34 years service.

Senator Graham claims to have seventy (70) other Senators on board supporting his proposed legislation. Estimates in the House are less than that number.

Senator Graham is currently on a fact finding tour in Iraq and Afghanistan visiting the troops with Senator McCain (R-AZ), Senator Clinton (D-NY) and Senator Feingold (D-WI).
